



Zoning Permit Application

While most building projects require a Building Permit, some, due to size or other factors, will require a Zoning Permit. A Zoning Permit is oriented to the **lot** and how a proposed building/structure including a fence will be located on the lot. Zoning Permits consider setbacks, size, lot coverage, and other City ordinances or regulations.

Complete this form and return it to City Hall along with the permit fee, and (if applicable) for the project a Site Plan.

Setback

The minimum horizontal distance between any portion of a structure or proposed structure and a property line, right-of-way, or easement.

Site plan required – A site plan is required with most zoning permit applications. See the back of this form for site plan requirements.

Property pins & property lines – It is the responsibility of the property owner to know the location of their property pins and property lines. If property pins cannot be located and property lines cannot be determined it is the responsibility of the property owner to have the property surveyed.

SITE PLAN REQUIREMENTS

A Site Plan is required with certain Building Permit Applications and with most Zoning Permit Applications. When completing your Site Plan, include the information listed below and use the Site Plan Example below as a reference.

1. Name, street address, and date.
2. North Arrow.
3. Property lines and lot dimensions.
4. Location, dimensions, and setback of all existing buildings and structures on the property.
5. Location, dimensions, and setback of the proposed building/structure.
6. Location of all adjacent streets, sidewalks, driveways, alleys, waterways, etc.
7. If applicable, location of all existing and proposed water lines, sanitary sewer lines, and storm water drainage systems.
8. Other information as may be requested or required.
